Form I Measures to provide warning to the population

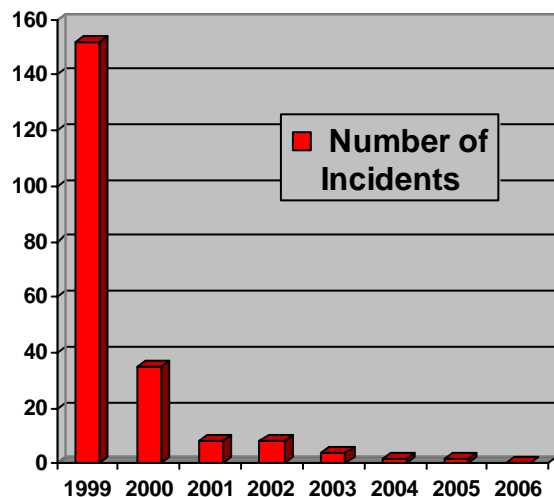
Article 7.1 "Each State Party shall report to the Secretary-General ... on:

- i) The measures taken to provide an immediate and effective warning to the population in relation to all areas identified under paragraph 2 of Article 5."

Remark: In accordance with Article 5, para.2: "Each State Party shall make every effort to identify all areas under its jurisdiction or control in which anti-personnel mines are known or suspected to be emplaced and shall ensure as soon as possible that all anti-personnel mines in mined areas under its jurisdiction or control are perimeter-marked, monitored and protected by fencing or other means, to ensure the effective exclusion of civilians, until all anti-personnel mines contained therein have been destroyed. The marking shall at least be to the standards set out in the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps and Other Devices, as amended on 3 May 1996, annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects".

The Mine Risk Education activities in 2006 were conducted by the local NGO Victims of Mines and Weapons Association (VMA) and the Albanian Red Cross (ARC) while monitored and coordinated by the Albanian Mine Action Executive, as the National Mine Action Authority.



No mine/UXO accidents with Albanian civilians were recorded during 2006.

The MRE Project implemented by VMA was funded by the US State Department through ITF.

The aim of the project was to keep 30,000 mine affected community members in 39 villages continuously informed about the mine & UXO threat through the 39 anti-mine community based committees established in these villages. The anti-mine committees have membership consisting of: village leader, nurse, teachers and peace activists (youth representative from school).

VMA team provided MRE materials to the mine affected communities on a regular basis including posters, leaflets etc. School based activities related to MRE were also organized and consisted of: competition among classes for the best poster, leaflets, songs, role plays, and information about mine fields, mine risk signs and environment issues. A mobile theatre with comedians traveled regularly from village to village to disseminate safety messages through comedies and parodies.

The Albanian Red Cross in consultation with AMAE published a poster with MRE messages for this year. The poster was distributed to the local areas in northeast Albania. The Albanian Red Cross volunteers were actively participating during the handover ceremonies of cleared land to the community. This project has been funded by ICRC.

Progress on Mine Victims Assistance in Albania

Year 2006 was important for the Mine Victim Assistance programme in Albania. The activities that took place under this component were continuously monitored and coordinated by AMAE with the relevant partners (including the Ministry of Health, Kukes Regional Hospital, Hospital districts of Has and Tropoja, Directories of Primary Health Care of Kukes Has and Tropoja, the National Orthotic Prosthetic Center (NOPC) in Tirana, Albanian Disability Rights Foundation (ADRF), ICRC-SFD, VMA, ITF, the Slovenian Institute of Rehabilitation).

Major highlights in the area of victim assistance for 2006 include:

- The National Strategy on Disability published in January 2005 is being followed closely by the VA programme; awareness is being raised amongst the mine victims about this new strategy and mine survivors' rights. A Conference of Ministers was held in June 2006 during which all Ministries reported on the progress made towards achieving the goals set forth in the National Strategy on Persons with Disabilities, which mine survivors are a part of.
- The third Albanian Night of 1000 Dinners, a global fundraising event for Mine Action, took place in June 2006, hosted by the US Embassy in Albania. Individual donors including governmental authorities, local private businesses, the diplomatic community, NGOs, etc, donated over \$16,870 from 32 individual donors. Out of the total money raised this year, \$ US 2,523 was sent to Adopt –A-Minefield Better World Fund, while \$ US 14,250 will be matched and used to assist 8 youth mine survivors to continue their school and post secondary studies, as well as provide physical rehabilitation and medical treatment for 2 mine victims. The US DoS matched these funds through ITF for the total of \$ 28,500 which will be used in 2007. AMAE will coordinate and monitor closely with the local NGO- VMA the implementation of the project.
- The French Government provided 50,000 Euro in February 2006 through UNDP, to implement a project for improving emergency and ongoing medical assistance in Northeast Albania for mine/UXO victims. The project implemented during 2006 has greatly assisted the nurses working in the CBR network and the physiotherapists of Kukes, Has and Tropoja through provision of equipment and supplies to the mine affected villages and the physiotherapy department at Kukes Hospital. Under this project 6 nurses from the mine affected villages and two physiotherapists from Kukes and Tropoja , were send for training for a period of three weeks to Slovenia.

- The US DoS through ITF has provided funding for the second year of the ‘Establishing house-hold economies’ project which assisted 31 mine/UXO survivors during 2006 through animal husbandry. The project has been implemented successfully.
- The US DoS through ITF also funded a project during 2006-2007 for improving social and medical services through various trainings of mine /UXO Survivors to better care for their prostheses provide logistic support for them in case they need to come from mine affected villages to the districts’ hospitals.
- At the end of May 2006, the Ministry of Health and Ministry of Education in cooperation with Handicap International and the medical faculty in Tirana has launched the project for building a Physical Medicine and Rehabilitation capacity in Albania. The time frame for this project is 2006-2008, and it is being funded by USDoS through ITF, the Albanian Government and Handicap International. The project will provide training to prostheses/ orthotic technicians, according to International Standards and upgrade them to level II category, as well as establish a programme for training physiotherapists at the Faculty of Nursing in Tirana and establish a Rehabilitation Centre in Kukes Hospital.
- Funding made available from EC through UNDP; VMA is implementing a project to provide 30 mine survivors with vocational trainings in jobs such as small electronic repairs, hairdressing, computers, etc. The project will greatly assist in the economic reintegration of mine/UXO survivors.
- With funds made available from the EC through UNDP, raw materials and supplies are provided in December 2006, to the National Prosthetic/orthotic Center in Tirana and the Prostheses Support Center in Kukes.
- 20 mine/UXO amputees received treatment at the Slovenian Institute of Rehabilitation as considered difficult cases that could not be assisted at the National Prosthetic Orthotic Center in Tirana (NPOC).
- ICRC-SFD continued their support to the NPOC through the provision of raw materials, technical assistance, and training of one more technician in Bangalore, India.

ANTI PERSONNEL MINES AND THEIR DESTRUCTION**

Based on articles 78, 81 point 1 and 122 point 1 of the Constitution, upon proposal of the Council of Ministers

**THE PARLIAMENT
OF THE REPUBLIC OF ALBANIA**

DECIDED:

**Article 1
Object**

This law determines the authority, responsibilities and the functions of the entities required for the fulfillment of the obligations deriving from the “Convention on the Ban of Use, Stockpile, Production and Transfer of the anti-personnel mines (APM) and their destruction” in the Republic of Albania, as a state party and which herein under will be referred as “the Convention”.

**Article 2
Competencies of the Government Authority to the implementation of the Convention**

1. The Minister of Defense is the government authority of the Republic of Albania responsible for the implementation of the Convention.

2. The Government authority cooperates with all national and international organizations, to the full implementation of the Convention.
3. The Government Authority in case of discovering mined areas or suspected to be mined, orders to take all measures to secure, fence and place visible marking signs to the area as well to inform, warn with any possible mean the civilian population of the area.

Article 3
Obligation on the declaration of the activity
and verification by the government authority

1. The physical or juridical body, national or international, carrying out the activity allowed at article 8, point 2 of this law, is required to give all information on his/its activity through an annual statement, according to the form issued by the government authority.
2. The physical or juridical body, national or international, in addition to the information given in accordance with point 1 of this article, is required to give, whenever is requested by the government authority, all information on his/its activity when this latter contains elements covered by the Convention, in order to verify that the activity is carried out in compliance with the requirements of the Convention and this law.

Article 4
International Inspection

The international inspection is carried out by the inspectors of the Evaluation Mission of the United Nations Organization and is carried out in presence of a local group which is leaded by the representative of the government authority.

Article 5
Cooperation

1. The entities that possess or are suspected to possess anti-personnel mines of any type are required to allow inspections and to cooperate with the inspectors.

The entities make available to the inspection team or the authorized person:

- a) all information requested for purposes of the inspection
- b) the telecommunication means, working premises, transport means needed for movement within these premises for purposes of the inspection.
- c) The relevant documentation for the parts and objects under inspection.

In addition the entities are required to:

- take security measures during the inspection (to protect the life and health of the inspectors);
- contribute to the evaluation of the preliminary results of the inspection and in clarifying suspicious issues.

Article 6

Inspections

The teams of the UN Evaluation Mission in the territory of the Republic of Albania are allowed to:

- a) Have free access during the normal working hours to the premises where is located the subject under inspection.
- b) Carry out all investigation needed for the inspection and gather all information useful to this purpose, by interrogating, when is necessary, the personnel of the entity under inspection.
- c) Control documents, materials, packing and registers of the products found in the entity;
- d) Request information regarding the movement of all transport means entering and leaving the entity under inspection.

Article 7

Responsibilities of the accompanying group

The local accompanying group takes all necessary measures for a sudden and effective inspection, without violating the interests of the owner or the manager of the entity under inspection.

The group has the following responsibilities:

- a) creates the conditions needed for inspection
- b) protects the information, classified as “state secret”, and conserves the confidentiality
- c) Makes a clear classification of all data into the disposition of the inspection team.
- d) Takes decisions for making available to the inspection team of all classified information in accordance with the Law nr.8457, date 11.02.1999 “On the information classified as State Secret” and the sub legal acts in force;
- e) Discusses with the inspection team the application of special procedures in cases envisaged by article 8, point 14 of the Convention.

Article 8

Prohibited activities and exceptions

1. The physical and juridical bodies, national and international, ***are prohibited*** in all cases to:
 - a) develop, produce, buy, storage, possess antipersonnel mines or transfer those, directly or indirectly to other bodies;
 - b) use antipersonnel mines;
 - c) help, encourage or force, in any mean, other bodies to participate in any activity prohibited for a state signatory to the Convention;
 - d) transfer to or receive antipersonnel mines from state non-parties to the Convention;
2. The processing, transfer, use and storage of the anti personnel mines is allowed if the activity has purposes of:
 - a) training
 - b) clearance
 - c) mine destruction technique

The activity allowed according to point 2 of this article, is approved by order of the Government Authority.

Article 9
Administrative violations and their execution

1. Non-compliance with the obligations of the convention and with the article 3 and 89 of this law, when actions do not contain elements of criminal offences envisaged in articles 278 and 278/a of the Penal Code, is considered administrative violation and is penalized with a fine from 100,000 to 300,000 Leke.
2. The fines envisaged at point 1 of this article are authority of the Control Body which is established and functions upon order of Government Authority.
3. The entities, which are fined based on this article for administrative violation, have the right to claim to the Government Authority, who establishes a special commission to examine these claims.
4. The examination of the administrative violations, the claim on the decisions of the Government Authority and the fine execution are made in compliance with the dispositions of the law nr. 7687, date 07.04.1993 "On the administrative violations" amended as well the Administrative and the Civil Code.

Article 10
Issue of the acts

The Ministry of Defense is responsible for issuing the sub-legal acts needed to implement the articles 8 and 9 of this law.

Article 11
Entry into force

This law enters into force 15 days after publication in the Official Gazette.
